## Minutes of the Parish Council Meeting Held on Thursday 20 October 2011 in Amy Robsart Hall

#### 2. Parishioner's Time

- John Felmingham asked who's responsibility it is to apply the salt provided in the yellow bins when required. Chairman confirmed that the salt is provided by Norfolk County Council, but it is for the parishioners to apply the salt as and when required. Resolved for Clerk to contact Sally Bettinson (NCC) with regard to availability of a 'post snow grit' rather than the current 'pre snow grit'. Once this is established insert information regarding the yellow salt bins in the next newsletter to clarify that it is up to parishioners to make use of the salt provided as no spreading service is provided by NCC.
- 2.2 John Felmingham raised concerns regarding a 42 foot lorry travelling down Creake Road and trying to access The Street. Chairman explained that lorry routes to be discussed under Agenda Item 5.1.
- 3. Declarations of Interest

Cllr Ms Thompson declared interest in Item 6.1. Chairman declared interest in Item 6.1 and Item 8.1.

- 4. Minutes of September Council Meeting held on 15 September 2011
  Minutes of the above meeting had been circulated. **Resolved to approve the Minutes.**
- 5. Ongoing Items from the Minutes
  - 5.1 Lorry route signs

Chairman explained that on 19 October a meeting was held with Sally Bettinson to discuss this topic. Sally appreciated the problem caused by large vehicles passing through the village and has agreed to install three lorry route signs funded by NCC. Installation is expected within 4-6 weeks. **Resolved Clerk to write to local farmers after installation of signs to advise of heavy vehicle routes**.

5.2 Tattersett road surface

Clerk reported that NCC Highways are to resurface the road in 2012, but are unable to provide kerbing. Resolved Clerk to clarify to Richard Fletcher (NCC) the exact area to be resurfaced.

5.3 Parish Newsletter

Clerk advised that as yet no volunteers have come forward from the Village Hall and Church Groups to carry out the Newsletter typesetting.

### 6. Planning Matters

- 6.1 Chiplow and Jack's Lane Wind Farms update
  Letter received and noted from BCKL&WN re the joint Public Inquiry. This subject was
  discussed at length at the meeting. Chairman advised that the decision will be taken
  by a four week Public Inquiry which will commence on 31 January 2012 and a decision
  is expected in April 2012.
- 6.2 BCKL&WN Site Specific Allocations
  Chairman explained that the LDF structure plan documents future planning for the next 15 years. Under the Site Specific Allocations five houses are proposed to be built in Syderstone Parish. Chairman confirmed that the SSA details have been posted on the Parish Notice Boards and the Village Website. Resolved no consultation comments to be made by the Parish Council.
- 6.3 Planning application:- remove existing lean-to and erect conservatory at rear of public house at The Lynn Arms

  Chairman confirmed that application to be deferred as it has been invalidated.

  Letter received and noted at the meeting. Resolved Clerk to write to R Harding
  (BCKL&WN Chief Executive), N Daubney (BCKL&WN Leader) and V Spikings
  (Planning Committee Chairperson) enquiring as to why there was no prior
  consultation with the Parish Councils before making the decisions stated in the
  letter received.

    Chairman explained the letter received regarding the invitation by NCC to Parish Councils to submit bids for small improvement schemes such as footways, trods and crossing facilities. Bids to be made by 20 January 2012. Funding has also become available for Vehicle Activated Signs. Resolved all agreed for a bid for one Vehicle Activated Sign for Syderstone. Chairman explained that Sally Bettinson (NCC) is attempting to obtain a temporary speeding sign for The Street installed for a 4 week period. Resolved Chairman to establish if a trod could be provided from 14 Creake Road to the farm gate (100m length).

    Letter received and noted at the meeting. Cllr Chenery explained that under the proposals Norfolk would lose half of an MP to the Wisbech area, but basically our constituency remains unchanged.
